# Supervisor Update – Bob S. Brown

Spring has finally sprung, and I hope it is finding you well! As some of you may know, our wonderful Township Trustee Mr. Robert (Bob) St. Peter has retired from the Board.

I am not certain of Bob's next endeavors but whatever it is, I have no doubt he will be loved and appreciated. I truly will miss his knowledge, enthusiasm, and friendship. The Board is required to appoint a new Trustee to fulfill the remainder of Bob's term. We have received interest in the position and are setting the deadline for submission of letter of interest to the Township Clerk no later than May 20, 2022, 5:00 PM.

Once again it is time to clean up. As discussed in prior newsletters, the most common concerns the board receives from citizens are regarding derelict vehicles, pallets, furniture, and general debris in yards which are all contrary to our Zoning Ordinances. I ask that everyone please survey their property and remove the aforementioned items. By doing so, it will certainly ease neighbor tension, help property values, and will keep our area an attractive and enjoyable place for all our Dafter taxpayers. It should be noted, most of our property owners certainly do their diligence when it comes to maintaining their property and structures. On behalf of the Board and taxpayers, we send our sincerest gratitude.

The Township is funding another cleanup day on June  $18^{th}$ , 2022, 8:00am - 1:00pm. As in the past, we will be accepting one truck or normal trailer load of debris from each property in the township. Please bring valid identification so that we can verify each owner. We will also have a scrap metal dumpster to offset some of the cost to the township.

The township is working on the brining scheduled for this year along with some road maintenance on Maple and 11 Mile. The current estimates we received for 11 Mile between the tracks and Mackinac Trail, Maple Road between 10 and 11 Mile and Maple Road between 6 Mile and 9 Mile are approximately \$2,647,100 and township cost of approximately \$1,564,300. We just received the quotes and are working through them. Further, we are working on estimates to remodel/repair the main Fire Hall. We will keep you informed as things progress with these projects.

In closing, please be reminded that a Zoning permit is required for any new construction including additions, barns, garages, and such. If you are planning any building projects this year, please do not hesitate to contact me to help facilitate your project.
